Note Millage is shown in Decimal.

Millage is 1/1000th of a dollar. To obtain your Tax dollars you multiply your assessment by the millage.

For example: if your assessment is \$100,000 and the millage for your district is 2 (\$100,000 x .002 mills), then your tax bill is \$200.00

Who sets the millage rate? Each taxing district sets their own millage rate every year after it determines how much money it needs to operate.

The county, township and borough operate on a calendar year basis, January 1 through December 31.

The school operates on the fiscal year basis, that is July 1 through June 30th.
