

22nd Judicial District Language Access Complaint Form

Should a court client/customer feel that his/her rights to meaningful language access have not been met by the Court, the following procedure may be followed to register a complaint:

1. The person with the complaint (the complainant) should contact the 22nd Judicial District Language Access Coordinator to report the complaint by completing and submitting the attached Language Access Complaint Form.
