 - a) Motion to approve the salaries for the Wayne County Correctional Officers and Sergeants for 2021 as listed.
 - b) In accordance with the approved HSA compensation plan, a motion to promote Jessica Ramos to the position of Case Worker II at Wayne County Children and Youth Services, effective Jan. 24, 2022, for reaching 6 months as a Case Worker I and having a satisfactory employee performance review. Set her salary at \$18.83 an hour, or \$36,718.50

annually, for a 37.5-hour work week. This is a 35D on the adopted pay scale.

- c) In accordance with the approved HSA compensation plan, a motion to increase Lisa D. Janowski's salary for reaching 5 years with the county, effective Jan. 31, 2022. Motion to set Janowski's salary at \$14.10 an hour, or \$25,662 annually, for a 35-hour work week. This is a 29 C on the approved salary scale as a Cook II in the Human Services' Dietary Department.
- d) In accordance with the approved HSA compensation plan, a motion to increase Brenda Enslin's salary for reaching 5 years with the county, effective Jan. 31, 2022. Set her salary at \$15.03 an hour, or \$29,308 annually, for a 37.5-hour work week. This is a 29 D on the approved salary scale as a Social Services Aide III at Children and Youth Services.
- e) Motion to hire Brittany Highhouse as a Caseworker I at Wayne County Behavioral Health, effective January 24, 2022, for a 37.5-hour work week. Set her salary at \$16.48 per hour, or \$32,136 annually, a 33 C on the approved compensation scale.
