 - a) Motion to promote Deanna Owens to a Drug and Alcohol Prevention Specialist Trainee at Wayne County Drug and Alcohol Services, effective February 14, 2022 pending BTA approval. Set her salary at \$16.48 an hour for a 37.5-hour work week, a 33 C on the approved compensation plan.
