The regular meeting of the Wayne County Commissioners was held on this date with Commissioner Brian W. Smith presiding. The meeting was called to order by Chairman Smith with Commissioner James Shook and Commissioner Jocelyn Cramer present.

The Commissioners were presented with copies of minutes from the meeting held September 7, 2023. A motion was made by Commissioner Smith, seconded by Commissioner Cramer to approve the minutes for September 7, 2023. Commissioner Shook abstained. Motion carried.

Agenda

Scheduled to meet with the Commissioners: Wayne County Drug and Alcohol Administrator Jeff Zerechak, Recovery Support Specialist Jim Simpson, and Prevention Specialist Leslie Acker, and three Wayne County residents for the National Recovery Month Proclamation; Also attending for the proclamation was Lori Rescigno, Psych Rehab Director, and County Caseworker Kylie Emerson, Psych Rehab Program, with several consumers.

Requested was a new start date of September 18, 2023 for Melanie Goodwin. A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to amend the start date for Melanie Goodwin.

Requested was a new start date of September 12, 2023 for Corrine Crum at the Correctional Facility. A motion was made by Commissioner Cramer, seconded by Commissioner Shook and unanimous to amend the start date for Corrine Crum.

A motion was made by Commissioner Cramer, seconded by Commissioner Shook and unanimous to terminate Douglas Amann, Corrections Officer, effective September 11, 2023.

Received a letter of retirement from Cindy Furman, Wayne County Director of Elections, effective January 12, 2024. Comments were made from all three Commissioners praising the work she has done. They thanked her for creating an office succession plan and always

keeping Wayne County elections safe and secure. A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to accept this letter.

New Business

The Commissioners held an employee anniversary recognition. The following County employee was in attendance:

Miranda Willow, Fiscal Consultant for Human Services, was on hand to introduce Janis Daniels, Fiscal Technician, on her one-year anniversary with Wayne County. Ms. Willow called Ms. Daniels a tremendous asset to their department and praised her for being very positive in a very stressful position. The Commissioners thanked Ms. Daniels for her effectiveness the past year and noted having someone with her skills and demeanor is very important in that department. Ms. Daniels said the position has been a great thing for her. She loves the people she works with and enjoys coming to work.

Wayne County Drug and Alcohol Administrator Jeff Zerechak, Recovery Support Specialist Jim Simpson, and Prevention Specialist Leslie Acker were on hand, along with three Wayne County residents who received services from that department, for National Recovery Month. Amanda, who received services, said she has been sober for six years. She said she had to hit rock bottom before she had the wakeup call needed to get her life in order. Amanda said the Wayne County Drug and Alcohol Services is like a family to her. Another services client, Zack, said he is one year sober. After his second DUI he wound up in drug court and looking back that made all the difference for him. He is looking very much to continuing his path toward recovery and potentially help others. A third services client, James, said he is two years sober. He hit rock bottom and did not know where to go, so he called Wayne County Drug and Alcohol Services and he is so grateful he did. James offered praise for their staff.

Mr. Zerechak noted that many lives have been impacted thanks to Wayne County Drug and Alcohol efforts. He said they like to focus on the success stories and he is glad the three people at the meeting today were able to share their stories, which hopefully others will hear and can see that recovery from substance abuse disorder is possible.

Commissioner Cramer said that we all know someone in our lives that is struggling in this way and everyone gathered here today are shining examples of what recovery looks like and gives people the courage to pick up the phone and get help. Commissioner Smith thanked everyone for being here to offer their testimonials and to share their experience with addiction and recovery.

Also on hand for the proclamation was Lori Rescigno, Psych Rehab Director, and County Caseworker Kylie Emerson, Psych Rehab Program, with several consumers to talk about the behavioral health aspect of National Recovery Month. Ms. Rescigno said mental health stigma is still a big thing and she is so proud of the five individuals who came today to tell their story.

Consumers Debbie and Alexis spoke about their mental health history and how treatment and services have helped them. Ms. Rescigno said the struggle to find employment, dealing with anxiety and stress, and sometimes paranoia, impacts many that seek services at Psych Rehab. She said they try to get them to find hope and jobs and to integrate them back into the community. Ms. Emerson said mental illness is not something people are, it is something

people have, and having a support system in place and services available are important factors in recovery.

Commissioner Shook spoke about his own family member who deals with mental health issues and said he knows where people are coming from and understands what everyone is going through. He said he is very proud of the people that are here today to be able to tell their story and he hopes others find the same strength in their lives. A motion was made by Commissioner Smith, seconded by Commissioner Shook and unanimous to adopt the National Recovery Month Proclamation in Wayne County.

A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to approve the FY 2023-24 HSA Block Grant submission.

A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to approve 4th Quarter MATP report showing \$252,572 in total expenditures from April 1, 2023-June 30, 2023.

A motion was made by Commissioner Cramer, seconded by Commissioner Shook and unanimous to approve the submission of the renewal application for the Wayne County Psych Rehabilitation certification for Civil Rights Compliance.

A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to approve an agreement between the Wayne County District Attorney’s Office Detectives and the Highway Safety Network for use of grant funds for pedestrian safety efforts through the Northumberland Regional Police Traffic Services Grant for October 1, 2023-September 30, 2026.

A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to approve a professional services contract for broadband consulting with Lewis Strategic at the rate of \$3,000 per month from July 7, 2023, to June 6, 2024.

A motion was made by Commissioner Cramer, seconded by Commissioner Shook and unanimous to hire Jenna Mauder as a Watershed Specialist at the Wayne County Conservation District, effective September 25, 2023.
