eleven different meetings for those in need. John Nebzydoski said mental health services are available and are making progress. Daniel White, a client at the County's Psych Rehab Center, said he goes to the center daily and he appreciates the services they provide. Sheila Whitman said she was joining the proclamation proceeding to pay tribute to her son Tyler, who died by suicide a few years ago.

The Commissioners said they were very proud of the increased services available to county residents and they urge those in need to seek out the available services programs. A motion was made by Commissioner Smith, seconded by Commissioner Adams and unanimous to adopt the proclamation for Mental Health Awareness Week in Wayne County.

Fred Jackson, Wayne Memorial Community Health Centers, Midwives Heather Kellam, Patricia Konsman, Heather Mecone and Kara Poremba were on hand to discuss the expanding Midwifery Program with Wayne Memorial. Mr. Jackson said they have experienced a 9% growth in the program this year. He said our midwives deserve credit for their holistic and individualized approach. The Midwives touted the program and how thankful they are. The Commissioners said they are very proud of the program and thanked them for everything they are doing and are glad to hear about the expansion of the program. A motion was made by Commissioner Smith, seconded by Commissioner Cramer and unanimous to adopt the proclamation of Midwifery Week in Wayne County.

A motion was made by Commissioner Adams, seconded by Commissioner Cramer and unanimous to ratify a letter of support for a Department of Agriculture grant application for Wayne County Home Meats, LLC, for a facility in Sterling Township.

A motion was made by Commissioner Adams, seconded by Commissioner Cramer and unanimous to ratify a letter of support for Berlin Township's LSA Grant application.

A motion was made by Commissioner Cramer, seconded by Commissioner Adams and unanimous to ratify a renewal application for an existing certificate of compliance for Wayne County Behavioral Health's Psych Rehab facility for continued operations.

A motion was made by Commissioner Cramer, seconded by Commissioner Smith and unanimous to approve the Bureau of Elections' request to use Park Street as a polling place for Honesdale's 2<sup>nd</sup> Precinct on November 8, 2022.

A motion was made by Commissioner Cramer, seconded by Commissioner Adams and unanimous to adopt the 2022 Wayne County Continuity of Operations (COOP)/Continuity of Government (COG) plans. Commissioner Smith spoke about the importance of these plans and what they are used for. He said, in light of what is going on in Florida with the hurricane and flooding, it makes these documents vital for county operations if something like that were to happen here.

A motion was made by Commissioner Adams, seconded by Commissioner Smith to adopt Resolution 29-09-2022-A declaring Wayne County a Second Amendment County. Commissioner Cramer voted no. Motion carried. Commissioner Cramer said we are not legislators. We already swear an oath to obey the Constitution, including all of the amendments, so this resolution is unnecessary and she feels we mislead the public by doing this. Commissioner Adams said the resolution is an affirmation that we obey all the amendments of the Constitution and we support and defend all of them.

CFO Vicky Botjer detailed what the \$194,597 the County is applying for would be used for including parking area and safety upgrades, including lighting and cameras. Commissioner Adams offered his thanks to CFO Botjer for pivoting from one potential project to another and getting the application done so quickly. A motion was made by Commissioner Adams, seconded by Commissioner Cramer and unanimous to approve Resolution 29-09-2022-B to

file a Local Share Account Fund – Monroe County Application for Phase 2 – Industrial Point Development Project.

A motion was made by Commissioner Adams, seconded by Commissioner Cramer and unanimous to execute a financial commitment letter regarding Resolution 29-09-2022-B – Local Share Account Fund – Monroe County Application for Phase 2 – Industrial Point Development Project. CFO Vicky Botjer noted the Wayne County financial commitment is \$71,262.30.

A motion was made by Commissioner Cramer, seconded by Commissioner Adams and unanimous to hire Jamiela Feldman to the position of part-time Corrections Officer at the Wayne County Correctional Facility, effective October 11, 2022.

A motion was made by Commissioner Adams, seconded by Commissioner Cramer and unanimous to hire Marie DeSanti to the position of part-time Food Service Worker at the Wayne County Correctional Facility, effective October 11, 2022.
