Clinton Township Board of Supervisors Meeting

The special, advertised April 26, 2021 meeting, was called to order by Chairman James Zefran on April 14, 2021 at 7:00 PM, for the purpose of opening the grading and rolling, and materials bids and would be immediately followed with the advertised work session regarding Clinton Township roads. Chairman James Zefran, Vice Chair Brian Non, and Supervisor Russell Curtis were in attendance.

**A. Pledge of Allegiance** - The Pledge of Allegiance was recited.
