Clinton Township Board of Supervisors Meeting

The regular June meeting, was called to order by Vice Chair Non on June 9, 2021 at 7:00 PM. The meeting took place in the Clinton Township municipal building garage for purposes of social distancing. Chair Zefran, Vice Chair Brian Non, and Supervisor Russell Curtis were in attendance. Solicitor Jeffrey Treat was also in attendance.

**A. Pledge of Allegiance** - The Pledge of Allegiance was recited.

**B. Hearing Check**

**C. Minutes of Regular Meeting May 12, 2021** - *Vice Chair Non made a motion, seconded by Supervisor Russ Curtis to accept the minutes of regular May 12, 2021 meeting. All voted yes. The motion carried.*

**D. Public Comment –Items on Agenda Only** – Ray Vogt complemented the phenomenal grading that was done by WRM Enterprise.

**F. Correspondence** – Chair Zefran noted that Governor Wolfe had sent out notification that there was five days to fill out an application for COVID money that the township would have till 2024 to use. Attorney Treat said that at such time as Clinton Township has been approved for this funding the board should make a motion to open a separate account for that money because it will be necessary to show an accounting of all expenses paid from that account.

**G. Road Master Report** – Vice Chair and Road Master Brian Non reported that grading is underway and work is being done on Long Pond Road. Calcium is being done. The road-side mower broke down. Discussion ensued regarding options on how this should be handled. Rental costs for a mower range from \$1,500 a week or \$5,000 a month. Vice Chair Non noted that the cost for a new mower only is roughly \$16,000. Chair Zefran calculated that the purchase price compared to renting for six years without repairs and insurance made renting a good option. Vice Chair Non said that he would make phone calls and that he could mow at night. Dyberry Township will be paving Clinton Township's small portion of road over by Donnie Stiles. Engineer Weinberger will put bids out for road work. Clinton Township will hold a special meeting to open the bids. DCED Redevelopment Authority will be paving Brook Street next year with PennDOT specs and an environmental study will be needed. Vice Chair Non said that work on Burns Road is completed except for the shoulders being done. Chair Zefran noted that it would still need to be tar and chipped in the future. Ditch work on roads still needs to be done.

**H. New Business** – There was no new business.

**I. Treasurer's Report Including Bills for Payment** – There was a question regarding the amount of the E. R. Linde check with concern about whether it reflected the reserve taken out. Vice Chair Non said that he would check on it. *Vice Chair Non made a motion, seconded by Supervisor Curtis to pay the bills as presented with the exception of the E. R. Linde bill until the billing issue is resolved. All voted yes. The motion carried.*

**J. Browndale Fire Department** – Chief Debevec gave a report. A written report is on file.

**K. Old Business**

**a. Updates from Solicitor Treat** – Attorney Treat said that he was still waiting on having stumps color-marked with blue paint that shows stumps within our right-of-way regarding the matter of stumps left by PPL on Long Pond Road.

**L. Public Comment** – No public comment was made.

**M. Adjournment** – Prior to the meeting being adjourned there was a brief executive session, after which Solicitor Treat requested that the minutes reflect that the executive session regarded employee issues and was exempt from the Sunshine Law. *Vice Chair Non made a motion, seconded by Chair Zefran that the meeting be adjourned at 7:39 pm. All voted yes. The motion carried.*
