

May 9, 2022  
Clinton Township Board of Supervisors Meeting

The regular May meeting, was called to order by Chairman James Zefran on May 9, 2022 at 7:00 PM at the Clinton Township municipal building. Chairman James Zefran, Vice Chair Brian Non, and Supervisor Russell Curtis were in attendance.

**A. Pledge of Allegiance** - The Pledge of Allegiance was recited.

**B. Hearing Check (Meetings are audio and video recorded)** – The hearing check was done.

**C. Minutes of Regular Meeting April 13, 2022** –*Supervisor Russ Curtis made a motion, seconded by Chair Zefran to accept the minutes of regular April 13, 2022 meeting. All voted yes. The motion carried.*

**D. Public Comment –Items on Agenda Only** – No comments were made.

**E. Correspondence – Wayne County EMA will be holding the second quarter training meeting on May 18, 2022 at 6:30 pm at 43 Volunteer Drive, Honesdale, PA 18431. The meeting is open to EMC's, Secretary, and Supervisors** – This was noted. No Supervisors will be attending.

**F. New Business – Maps for the Poltanis subdivision are submitted by the Clinton Township Planning Commission for final approval** – It was decided that the maps would be signed after the meeting.

**G. Road Master Report** – Vice Chair and Road Master Non reported that there was a plan for widening Scubeck Road. With Tom Barrier's blessing we will extend the width of the road on the left a bit, as well as shave back the road. Dust control is an issue. Road Master Non reported that he has been in touch with Brad Shaffer and Laura Travis and that the state does not have a bid for dust control. If the county has a bid for it, we will piggy back off of them for calcium. Ron Poska inquired about Midland and was informed that Midland only does oil. Vice Chair Non noted that the backhoe is broken. Although we do have a small bucket for the backhoe, the workers would like to have forks for it to pick up pipe. He stated that Lapatosky is having an equipment auction on June 4, 2022. Chair Zefran said to get rid of everything we don't use. *Vice Chair Non made a motion, seconded by Supervisor Curtis, to sell unused equipment at Lapatosky's auction without a reserve. All voted yes. The motion carried.* *Vice Chair Non made a motion, seconded by Chair Zefran, to order forks, to be paid for with earnings from the used equipment sold at Lapatosky's auction with more funds added to it if need be. All voted yes. The motion carried.*

**H. Treasurer's Report Including Bills for Payment** – *Supervisor Curtis made a motion, seconded by Vice Chair Non to pay the bills and accept the treasurer's report. All voted yes. The motion carried.*

**I. Browndale Fire Department**- No representative was in attendance, but it was noted that a fund raiser chicken BBQ is coming up.

**J. Old Business**

**a. Hearing for Amendment to Ordinance No. 11-14-18** – *No public comments were made. Chair Zefran made a motion, seconded by Vice Chair Non to pass the Amendment to Ordinance No. 11-14-18. All voted yes. The motion carried.*

**b. Clinton Twp vs. Norris has been rescheduled on Tuesday, May 24, 2022** – This was noted.

**K. Public Comment** – Ron Poska asked about increasing his pay rate by fifty cents per hour so that his raise matches the \$1.00 per hour raise given to the non-CDL road workers which was given at the reorganization meeting of January 2022. Chair Zefran instructed Secretary Droppa to have Ron Poska's future pay checks reflect a fifty cent raise and to have that raise be retroactive to the beginning of the year.

**A. Adjournment** – The meeting was adjourned at 7:17 pm by Chair Zefran.
