INSTRUCTIONS TO VOTER:

- 1. To vote you must blacken the oval (●) completely. An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.
- 2. To vote for a person whose name is not on the ballot, you must blacken the oval to the left of the line provided, and write or print the name in the blank space provided for that purpose.
- 3. **Do Not** vote for more candidates than instructed for each office. An overvote will void your choice for that particular office.
- 4. To vote on a Retention Question, blacken the oval to the left of the word "YES" to vote **FOR** the retention. Blacken the oval to the left of the word "NO" to vote **AGAINST** the retention.
- 5. If you make a mistake, do not erase it. Ask for a new ballot.
- 6. Use a black or blue pen or pencil.
