3. **Do Not** vote for more candidates than instructed for each office. An overvote will void your choice for that particular office.
4. To vote on a Retention Question, blacken the oval to the left of the word "**YES**" to vote **FOR** the retention. Blacken the oval to the left of the word "**NO**" to vote **AGAINST** the retention.
5. If you make a mistake, do not erase it. Ask for a new ballot.
6. Use a black or blue pen or pencil.
